Brosseau exhibited during his career in the construction industry.

# Two (2) testing options:

1. In-person at Prometric testing center.

<u>Required</u> to bring your own mask and wear it during the exam. Testing center hours and appointments vary by region with reduced occupancy to assure safe social distancing within the exam seating.

2. Remote Proctored Testing (RPT). Secure, virtual, online monitored exam from your Continuing Education Learning Units (LUs):

Preparing for your remote exam A. Minimum Technology Requirements (must confirm prior to exam day):

- Windows 7 or MacOS 10.13 or higher
- Current version of Google Chrome
- 0.5 mbps internet connection Disconnected from a docking station, plugged directly into a power source
- Contain or be connected to a moveable web-camera
- Only one monitor is allowed. Computers with additional monitors must be configured in advance to support only one.
- Ensure you are on the same computer and in the same location for the exam, where you performed the first system check.

• A mirror – If using a web-camera built into your laptop, the mirror will be used as part of the security check

# **CERTIFICATIONS RENEWAL:**

The Construction Documents Technology (CDT<sup>®</sup>) designation is a a certification, not just a certificate!

To maintain your certifications:

- At least 24 Learning Units (LUs) within the three years leading up to your expiration date.
- Log your qualifying 24 Learning Units (LUs) into your CSI account
- Click the "Recertify/Reinstate" button
- Pay the recertification fee
- Applications take 5-7 days

# Continuing Education Learning Units (LUs):

- 100% of Learning Units (LUs) must pertain to the AECO industry and
  - a minimum of 50% must pertain to the body of knowledge related to each CSI credential.
- 0.25 is the minimum Learning Unit (LU) accepted.
- LUs must be both earned and submitted during the 3-year recertification cycle.
- Maintaining more than one CSI certification?
- A total of 24 Learning Units (LUs) are required for each certification.
- A maximum of 12 LUs (50%) may overlap; however, content must be relevant to each specific certification.
- To claim credit toward 2 credentials, simply check the box for <u>both</u> <u>credentials</u> when selecting "Certification Type" upon submission.
