Hi Tom,

I did want to give you an update on my attempts to rejuvenate the Erie and Northwest PA Chapter, now that COVid seems more or less under control. Prior to COVid, I had made some progress in identifying chapter members and prospects who might be interested in working to restart the chapter. However, when COVid hit, and we all lost the ability to meet in person, those efforts fell by the wayside. Severe restrictions on restaurants, bars, and other public facilities have continued in PA to this date, but are scheduled to be lessened on June 1.

I do not desire a legacy as the person who killed the Erie Chapter. I have spoken previously to you of the unfortunate series of events that led us to this point. I benefited greatly from my time as a CSI member, and know there are others in northwest PA who could benefit similarly. Therefore, I am planning to make a fresh attempt to rally those persons and others around restarting the chapter. Any ideas or suggestions from you or the Region brain trust would be appreciated. I have maintained the chapter assets, records, accounts, insurance, and tax returns, to facilitate handing off a functioning organization to new leadership, as soon as candidates can be identified and elections held.

With only about 20-30 current members and just a few identified prospects in our area, this will not be an easy job, however by focusing only on core tasks at first I think it is doable.
